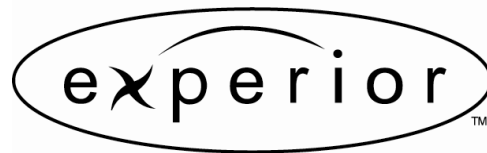

THE EXAMINATION PROCESS

You must be approved by the State of California prior to scheduling your examination.

Exam Scheduling Process Summary

- **Schedule Appointment:** You must call Experior to schedule your examination appointment.
- **Testing:** Take the exam on the day you have scheduled. Be sure to bring proper identification.
- **Exam Results:** You will receive your score results immediately upon completion of the exam.

Examination Administration through Experior

The state of California has contracted with Experior Assessments, LLC (Experior®) of St. Paul, Minn., to conduct its examination program. Candidates may test at any of Experior's eight California testing centers, which are located in San Diego, San Francisco, Fresno, Fremont, Rancho Cordova, Van Nuys, Cerritos and Colton. Other testing site locations may be added, based on anticipated statewide candidate volume.

Scheduling the Examination

APPOINTMENTS AND CANCELLATIONS

Upon receipt of your notice of eligibility (printed on the back cover of this handbook), you must arrange the time and place for taking your examination (original or retake) by calling 800.805.9123 between 5 a.m. and 6 p.m. (Pacific time). You may take your examination at any California Experior testing center. Please see the maps on Pages 7 and 9. Appointments are available six days per week at most centers. Schedule your test early to get your preferred site and time, preferably within 90 days from the date of your notice of eligibility.

If you miss or are late for your appointment, you will forfeit your examination fee. If you need to change it between the time of scheduling and the test date, you must contact Experior one full working day before your appointment to allow time to refill your appointment slot. You may reschedule your examination by calling Experior at 800.805.9123.

There is no testing on the following holidays or weekends on which the holiday falls:

- Independence Day and the day before
- Labor Day
- Thanksgiving Day and the day after

INTERNET SCHEDULING

You may schedule your examination online anytime after you have received your notice of eligibility using our Internet Scheduling Service at www.experioronline.com. To use this service on our Web site, follow these easy steps:

- Choose *California* from the list of states provided.
- Click on *Online Registration and Scheduling Services* to create your own user id and password.
- Follow the simple, step-by-step instructions to complete the registration process.
- Complete the process by scheduling your examination appointment online.

RESCHEDULING YOUR APPOINTMENT WITHOUT PENALTY

To change your appointment time, you must call Experior. There must be at least one full business day between the day of your call and the day of your appointment. **Please refer to the schedule below before you call. If you do not allow one full business day, you WILL forfeit your exam fee.**

CANCELING YOUR APPOINTMENT OR RESCHEDULING LATE

If you do not allow enough time in rescheduling your appointment (per the chart), you will forfeit your fee and must pay the fee again prior to choosing another appointment. All fees must be paid to the Division of Apprenticeship Standards. Please call Experior at 800.805.9123 to cancel or reschedule your appointment.

ABSENT FROM YOUR APPOINTMENT

If you miss your scheduled examination, you will forfeit your fee.

If you miss or are late arriving for your appointment, you will forfeit your exam fee. You will need to re-register for your exam.

EXAMINATION ELIGIBILITY EXPIRATION

FIRST TIME EXAMINEES: Examination eligibility expires, and an application is deemed abandoned, if the applicant fails to sit for examination within one year after being notified of eligibility.

RE-EXAMINATION APPLICANTS: Examination eligibility expires, and an application is deemed abandoned, if an applicant fails any written examination and does not retake the examination within one year from the date of that failure.

EMERGENCY CLOSING

In the event of severe weather or emergencies, Experior may need to cancel scheduled exams. In this situation, Experior personnel will attempt to contact you via telephone; however, you may check on test site closures by calling Experior registration at 800.805.9123. Exams will be rescheduled at your earliest convenience, without a rescheduling fee, if a site is closed by Experior.

RETAKE AN EXAM

If you do not pass the exam, you must re-apply using another application form. You must wait sixty days between examination attempts. To schedule your retake exam follow the procedures described above. Another exam fee must be paid to the Division.

Special Test Considerations

AMERICANS WITH DISABILITIES ACT (ADA)

If you require a testing accommodation under the *Americans with Disabilities Act* (ADA), please contact Experior to obtain an Accommodation Request Form. Reasonable testing accommodations are provided to allow candidates with documented disabilities, which are recognized under the *Americans with Disabilities Act* (ADA), an opportunity to demonstrate their skills and knowledge. Candidates should submit professional documentation of the disability with their application to help determine the necessary testing arrangements. Thirty days' advance notice is required for all testing arrangements. There is no additional charge for these accommodations.

Note: If English is your second language, a language barrier is not considered a disability.

Appeal Committee

Our goal at Experior is to provide a quality test and a pleasant testing experience to every candidate. If you are dissatisfied with either and believe we can correct the problem, we would like to hear from you. To facilitate this, we provide an opportunity at the end of your exam to make comments on screen at the testing centers, and your comments will be reviewed by Experior personnel, but you will not receive a direct response. You may also contact one of our Candidate Support Specialists at 800.805.9123 to discuss your concern, who will direct it to the individual most appropriate to respond.

We try to resolve candidate concerns at the testing site or on the phone whenever possible. If you feel that your concern has not been resolved, you must put your comments in writing to the following address:

If your concern is regarding the content of the exam, you must mail your concern to Experior, as only original signatures can be accepted. No faxes are allowed. If your concern is regarding scheduling or test administration (testing site procedures, equipment, personnel, etc.), you may either mail or fax your concern to Experior. In your letter, include your name, your Social Security number, the name of the exam, the date you tested and a specific description of your concern and the relevant facts surrounding it. Experior and the Division of Apprenticeship Standards will arrive at a resolution, and you will receive a response in writing from the Appeal Committee within 10 business days of receipt at Experior.

Taking the Examination

You do not need computer experience or typing skills to take this examination. You will have a personalized introduction to the testing system and an introductory lesson, which takes place on the computer, before you start your test.

You should arrive at least 15 minutes before your scheduled examination appointment in order to verify your identification, have your photo taken and allow time to sign in.

You must present one valid form of identification that meets all of the following criteria:

- current, valid and government-issued photo identification (driver's license, state-issued identification card or passport);
- the name on the government-issued photo identification must be the same as the name used to register for the examination (including designations such as "Jr." or "III," etc.); and
- must have a current photo and your signature.

FAILURE TO PROVIDE APPROPRIATE IDENTIFICATION AT THE TIME OF THE EXAMINATION IS CONSIDERED A MISSED APPOINTMENT. If you cannot provide the identification as listed above, contact Exporior before scheduling your exam appointment to arrange for an alternative way to meet this requirement.

SECURITY PROCEDURES

The following security procedures will apply during the examination(s):

- no cameras, notes, tape recorders, pagers or cellular phones are allowed in the testing room;
- no guests, visitors or family members are allowed in the testing or reception areas; and
- no valuables, weapons or other personal items should be brought to the testing center. Exporior is not responsible for items left in the reception area.

Sample Questions

The questions that will appear on your examination are multiple-choice and give you four options from which to choose your answer. The examination will contain questions with three different multiple-choice formats. A sample of each format is shown below. *An asterisk (*) indicates the correct answer.*

FORMAT 1—DIRECT QUESTION

Which of the following saws is used for making straight angle cuts on moldings?

1. Keyhole
2. Coping
- * 3. Miter
4. Hack

FORMAT 2—INCOMPLETE SENTENCE

The quarterly report of withheld taxes and FICA taxes for the period starting April 1 and ending June 30 is due

1. June 30.
2. at the end of each month.
- * 3. July 31.
4. 15 days after the close of the quarter, or July 15.

FORMAT 3—ALL OF THE FOLLOWING EXCEPT

Provisions shall be made to indicate the flow of water in a sprinkler system under all of the following conditions EXCEPT

- * 1. movement in the system due to a surge.
2. a leak equal to the output of the smallest sprinkler in the system.
3. discharge by one or more sprinklers.
4. flow of water equal to the output of the largest sprinkler in the system.

Understanding the Examination Results

EXAMINATION SCORE REPORT

Your score will be based on the number of questions you answer correctly. Be sure to choose an answer for each question. A minimum score of **70 percent** correct is required to pass your examination.

At the end of your examination, your score will be shown on the screen and you will receive a printed score report. Whether you pass or fail the exam, the report will give the numerical percentage of questions answered correctly and the actual number of questions answered correctly. In addition, the score report will show how well you did in each separate area of the exam. This will help you assess your areas of strength and weakness.

Your total percentage score is computed by dividing the number of questions you answered correctly by the total number of questions in the exam. The total score is *NOT* computed by adding the subscore percentages and dividing by the total number of subsections.

Exam reports are transmitted electronically to the Division of Apprenticeship Standards. Exam grades are confidential.

After Passing the Exam

YOUR CERTIFICATION CARD

Your passing score report identifies you as certified until such time as you receive your permanent certification card. Your certification card will be mailed, within two weeks following the examination, to the address you have provided to the Division of Apprenticeship Standards.
